# 1. Background

Ceylon Shipping Corporation Limited (CSCL), a fully government-owned commercial entity, is seeking qualified and reputable insurance providers from both private and public sectors, registered under the Insurance Regulatory Commission of Sri Lanka (IRCSL), to provide **Freight Forwarder's Liability Insurance Cover for the year 2025**. This insurance coverage is essential to safeguard CSCL against specific risks associated with its operations as an Ocean Freight Forwarder, Non-Vessel Operating Common Carrier (NVOCC) Operator, and Air Freight Forwarder.

# 2. Objective of the Insurance Coverage

The purpose of this insurance is to ensure financial protection and liability coverage for CSCL in the event of unforeseen claims arising from errors, omissions, and cargo-related risks. Bidders must demonstrate their capacity to provide comprehensive insurance coverage and meet the specified requirements in this bid invitation.

# 3. Insurance Requirements and Scope of Coverage

The insurance policy must cover the following risks and meet the required limits as outlined below:

# • All Risk Cargo Liability

Coverage for all cargo-related risks encountered by CSCL within its freight forwarding operations.

Limit of Liability: USD 100,000.00

# • Errors and Omissions Liability

Coverage for potential errors, omissions, and negligence during the execution of freight forwarding services.

Limit of Liability: USD 50,000.00

#### 3.1 Services to be Covered:

The selected insurance policy must cover CSCL's operations as:

- Ocean Freight Forwarder
- Non-Vessel Operating Common Carrier (NVOCC) Operator
- Air Freight Forwarder

#### 3.2 Contract Period

The insurance contract shall be effective for a period of one year:

Commencement Date: January 1, 2025

End Date: December 31, 2025

# 4. Geographical Coverage

The insurance policy must provide worldwide coverage for CSCL's freight forwarding operations, with the exclusion of JWC-declared high-risk areas. Bidders should confirm their understanding of JWC-declared areas and acknowledge this exclusion within their proposal.

# 5. Exclusions, Limitations, and Deductibles

#### 5.1 Exclusions

Bidders must clearly list and specify any exclusions that may apply to this coverage. These exclusions should be explicitly stated within the proposal to allow for comprehensive evaluation.

# 5.2 Limitations of Liability

Any limitations in liability coverage should be fully disclosed within the bid. These limitations will be assessed during the evaluation process to ensure they are consistent with CSCL's requirements.

#### 5.3 Deductibles

Bidders are required to specify any deductible amounts that would apply per event. CSCL will evaluate these deductibles to ensure alignment with the corporation's risk tolerance.

### 6. Claim Notification and Processing

The bid should include a detailed outline of the claim notification process and specify the time period allowed for notifying the insurer following an incident. Clear procedures for claim submission, processing timelines, and points of contact should be outlined.

#### 8. Evaluation Criteria

All bids will be evaluated based on the following criteria:

- Compliance with the stated coverage requirements
- Policy exclusions, limitations, and deductibles
- Premium cost and payment terms
- Responsiveness of the claim notification process and support services
- Financial stability and reputation of the insurer
- Experience in providing liability insurance within the shipping and logistics sectors

The Department Procurement Committee reserves the right to seek further clarification on any aspect of the bids and make inquiries to ensure the proposals meet CSCL's standards and requirements. The decision of the Committee is final and conclusive.
