1. Invitation for Bids

Ceylon Shipping Corporation Limited (CSCL), a fully government-owned commercial entity, hereby invites sealed quotations from qualified and experienced local insurance companies to submit bids for providing Protection & Indemnity (P&I) and Freight, Demurrage & Defence (FD&D) insurance covers for its owned vessels, Mv. Ceylon Breeze and Mv. Ceylon Princess, for the period commencing 24:00 hours on 20th February 2026 to 24:00 hours on 20th February 2027.

2. Scope of Insurance Cover

A. Protection & Indemnity (P&I) Cover: Comprehensive liability coverage, including but not limited to crew claims, pollution, wreck removal, cargo liabilities, fines, and collision liabilities (both 1/4th and 4/4th).

B. Freight, Demurrage & Defence (FD&D) Cover: Legal cost coverage for disputes related to the operation of the vessels, including charter party disputes, cargo claims, and other operational matters.

- B. Audited financial statements of the local insurance company and reinsurers.

3.4 Bid Security:

- A. A bid security equivalent to 1% of the total contract price (total premium) valid for two months from the bid opening date must be provided by a licensed commercial bank operating in Sri Lanka. The security should follow the format in **Form D.**

3.5 Submission Format:

- A. Quotations must be submitted using **Form B** (Quotation Format) and **Form C** (Compliance Sheet) on the company’s letterhead and signed by an authorized representative.

3.6 Payment Terms:

- A. Premiums will be payable quarterly in LKR terms based on the USD exchange rate on the invoice date.
- B. 50% of insurance claims will be settled in USD terms.

3.7 Bidder Representation:

- A. One representative of the insurance company may attend the bid opening.

4. Evaluation and Award Criteria

- A. Bids will be evaluated on:
 - a. Financial stability of the bidder and reinsurer.
 - b. Coverage offered and adherence to requirements.
 - c. Competitive pricing.
 - d. Track record and claims handling performance.
- B. Only quotations from the head office of respective bidders will be considered.
- C. The decision of the Department Procurement Committee is final and binding. The subject Bid Endorsement should follow the format in **Form A**.
